Item #1 - Discussion and Vote on the Emergency Procurement of Repairs to Septage Holding Tank #2 Drain Line.

The Director gave the Commissioners an update regarding current emergency condition of Septage Holding Tank #2 Drain. There was discussion related to the wet, sandy soil conditions surrounding sink hole near the drain and the uncertain location of other pipes in the same area. She reviewed the proposed repairs, contract specifications and cost.

Following a brief discussion, a motion was made by Chairman Downing and seconded by Commissioner Cataldo to authorize the Executive Director to sign on the Commissioners behalf the contract with RJV Construction Corporation for repairs to Septage Holding Tank #2 Drain

Line in the amount of \$31,800 with the understanding that there may be an additional \$10,000 should another day work be required. The Chairman requested the minutes from this meeting be attached to the signed contract.
