Minutes from December 15, 2022 Monthly Meeting - 3:00 p.m.

The meeting was held in the John McCahill Conference Room at the District's treatment facility. In attendance were, Chairman David C. Formato, District Commissioners Douglas M. Downing and Mark Cataldo and Executive Director Elizabeth Taglieri, Engineer Kristen Mucciarone and Executive Secretary Barbara W. Maffeo. Ellen Rosenfeld, Town of Millis Select Board member and Christopher Petrini of Petrini and Associates were also in attendance. Commissioners Wolfgang Bauer and Ted Kenney were not in attendance.

Agenda Item #2 -Update on Cured in Place Pipe (CIPP) and Manhole Rehabilitation in the Mine Brook Interceptor ((MBI) Subsystem.

The cured in place pipe lining was completed the week November 14, 2022. The Director is awaiting the pre and post video from National Water Main. One item was discovered in one of the manholes after the work was completed. A 48-inch pipe comes into this manhole at a higher elevation and drops like a waterfall. At the end of this pipe there is an overflow brick wall which was not shown in the record drawings. This is the source of the hydrogen sulfide gas resulting in the erosion in the pipe. The work was identified too late to allow for a change order to be performed. The District is awaiting a price estimate for the brick repair and will be considered to be incorporated in future Inflow/Infiltration (I/I) work to be completed.

Agenda Item #3 - Discussion and Vote to Amend the CRPCD Sewer Use Regulations.

The District's environmental lawyers and the Region One representative from the United States Environmental Agency (USEPA) have reviewed the aforementioned. The Director reviewed the changes with the Board. The proposed amendments have been emailed to the superintendents at member town Department of Public Works (DPW). The Director will highlight changes and

solicit comments from the Town Administrators and DPW Directors and bring them forward at a later meeting.

A motion was made by Commissioner Downing and seconded by Commissioner Cataldo to table discussion related to the proposed amendments to the CRPCD Sewer Use Regulations until the January 2023 Board Meeting.

- c. Update on Tree Plantings and Removal of Trees at Aeration Tanks. The cost of the trees was just over \$10,000 and will be reflected as a capital expense. The tree plantings are completed and the Medway Conservation Committee has inspected the site. Going forward the Medway Conservation Agent will perform an inspection twice a year for two years to ensure the trees are healthy.
- d. Update on Current District Staffing Levels. On November 30, 2022 a maintenance worker was terminated. The position will not be filled immediately.
- e. Septage Review. The Director answered questions from the Board related to septage amounts for 2022–2023.
- f. New Medway CRPCD Commissioner. Mr. Ted Kenney will join the Board of Commissioners as the new Commissioner for the Town of Medway at the CRPCD.
- g. Schedule Meeting for January, February and March of 2023. Meetings have been scheduled for January 10th, February 16th and March 16, 2023. The meetings are at 3:00 p.m. in the John McCahill Conference Room at the Charles River Pollution Control District.
