A. APPROVAL OF MINUTES from June 9th, approved as amended (6-0).

- E. DISCUSSIONS/VOTES
 - 1. Siding for museum building: the residing will take place soon. Work to be done by the Town.
 - 2. Wedding dress display: We agreed on a takedown date of August 29th and 30th. This prompted a policy question: do we want to include dresses that do not have a Franklin connection? Mary felt they should have a Franklin connection. This would mean that in the future we would only accession dresses that have a Franklin connection. We also discussed having a narrower theme, such as dresses from a specific decade, or specifically mother/daughter pairs of dresses.
 - 3. Old South Franklin Meeting House We would like Jeff Nutting to attend our next meeting to discuss this. We brainstormed about some possible future uses for this venue:
 - · writing workshops
 - music performance venue
 - military museum
 - an art gallery (supported by the Franklin Arts Council)
 - an industrial museum
 - · church history museum
 - · weddings
 - · Stanley Chilson museum
 - a multi-use venue for local cultural organizations
 - · specialty groups
 - local theatre productions

F. SUBCOMMITTEE REPORTS

- 1. Franklin Arts Festival (July 25th Aug. 2nd) We agreed to target one day to participate: Sunday August 2nd. Activities/demonstrations we'll offer: rug braiding (by Phyllis), wool spinning (Nancy Zazza), straw braiding (no one yet). Activities can take place on the front porch.
- 2. PastPerfect (Bob) Bob has been working with John Campbell on clearing the accessions backlog and adding to the database. The Commission agreed to allow PastPerfect users to enter all items in each basement cabinet, one at a time.
- 3. Adding 78 RPM records to PastPerfect An open question what requirements does PP have when entering old audio recordings? Knowing this will help Phyllis and Mary know how to construct their Excel spreadsheet of our audio recordings. One possibility is not to create an Excel spreadsheet at all simply enter them directly into PP.
