D. PRESENTATIONS

- 1. Nicole Nietzel, Curator. Some short term plans:
 - Open shelving (accessible from both sides)
 - · Remove some of the tables near the back
 - Make better use of vertical space
 - Create an area for object processing and cleaning
 - · Add to the PastPerfect database
 - Things on tables would go into permanent shelving
 - Possibly activate the vault. (Mary will ask Brutus and Gus about this.)
 - Sort items into groups: emphasis on Franklin-specific objects, objects to be deaccessioned, label non-historic items as 'not part of our collection'
 - In general, our current wooden cabinets should contain only items that are not part of our collection
 - Invest in the Nomenclature 4.0 book (\$115.), which provides definitive terminology of any/all objects.
- 2. Alan Earls, Charles River Meadowlands project (<u>www.charlesrivermeadowlands.org</u>):
 - US Army Corp of Engineers build dams. Bought the land between Rt. 495 and Pond St., and a parcel west of the highway, for flood control.
 - Alan is organizing a meeting to take place in September. He's found that in a survey of the 72 largest towns in Massachusetts, Franklin ranks second to last in walkability. A multi-town effort (Franklin, Medway, Bellingham) could make that unspoiled acreage a resource all could enjoy.
