#### **New Business**

Four Corners Site

Brona Simon of the Massachusetts Historical Commission acknowledged in writing her receipt of the Memorandum of Agreement we sent her that outlines the compensatory measures we will have taken regarding the Four Corners School.

Attending this month's meeting as part of the Four Corners site project:

Sandy Worcester -- Photo specialist and member of Southboro Hist Comm, who wrote a historical description of the Four Corners School. She took many wonderful pictures of the school, and will provide her written description and photos to the Historical Commission in hardcopy and online form.

New details about the compensatory measures:

- Recordation, to provide photographic documentation of the existing structure: This is what Sandy W. is providing.
- Post-demolition salvage of the school's cupola, if possible: The cupola measures 4' x 6' x 12'. Del will ask the DPW whether we can have the cupola moved to a DPW controlled site.
- Creation of an interpretive plaque at the site. The Commission has now decided to have a freestanding interpretive plaque at the site of the new Walgreens to commemorate the Four Corners School (rather than a plaque outside the entranceway).

### Refurbishing the Museum (80 West Central St.)

- The Town has made preliminary estimates for this work. These have tended to be high.
- We may want to consider using doors from the Four Corners School demolition (slated for June '09) for use in the new museum, perhaps for the library section in the southeast corner.
- To lower costs, we discussed doing without new clapboards on some sections of the exterior of the new museum
- We need to change the sign at the old museum to notify people of the location of the new museum.



## **Museum Inventory**

Mona and Dianne continue to work on inventory, including categorizing photos by decade. Later we can also categorize by theme (people, schools, and so on).

A new copier is available and needs a home. The Commission voted to acquire this important resource for the museum.
