Motion is made by Commissioner Feeley second by Commissioner Brunelli, to accept the Minutes of the Regular Meeting of February 7, 2022. All in favor. So voted.

ACCOUNTS PAYABLE

Motion is made by Commissioner Feeley second by Commissioner Brunelli to approve Accounts Payable for February 2022 totaling \$80,805.97. Check numbers 26406 to 26442. All in favor. So voted.

Motion is made by Commissioner Feeley, second by Commissioner Padula to approve the credit card purchases for January 2022 totaling \$634.97. All in favor. So voted.

FACILITIES & MODERNIZATION SUPERVISOR REPORT —

- Sean Pope began his report by notifying the Board Members that his staff have been extremely challenged by having to come in for snow storms and ice for 4-5 weekends in a row, including a blizzard. Staff has been prompt, have worked tirelessly without complaint and diligent in getting the necessary work done to keep the property safe. Supervisor Pope commends his staff for their teamwork on these weekends and during regular hours. The team works well together.
- Fire Alarm and 667-2 Roof Replacement projects are complete. A new restroom renovation project will begin at the large community hall. Also, a Winter Street Roof Replacement project will soon begin with design.

- 200-1 Development furnace replacement Project Low bidder has been approved and accepted. DHCD has increased the funding and we expect to have a meeting in the next 2 weeks to proceed.
- Emergency Boiler Replacement Project at Winter Street We received 2 bids. The low bidder is Aalanco Service Corp for the amount of \$47,400. This will include paying wage rates and a temporary heat source if needed. This project is funded through DHCD Emergency Funds. Motion is made by Commissioner Feeley, second by Commissioner Brunelli to accept Aalanco Service Corp. in the amount of \$47, 400. All in favor. So voted.
- Fire Units have been cleared by the building inspector. Units are expected to be available soon.

DIRECTOR REPORT

- Commissioner Training –Review of upcoming training modules.
- Virtual Legislative Day MassNAHRO Virtual Public Housing Advocacy Day is scheduled for March 22nd from 10:00 am to noon.
- MassNAHRO Annual Conference Scheduled for May 22-25 at the Sea Crest Hotel.
- COVID Test kits were received from the state for our residents and will be handed out this week by the Service Coordinators.
- Encroachment on FHA Land Members are notified that a neighbor has erected a structure partly on FHA land. We have asked the Town to enforce the Town Ordinance regarding this. We do not have any further information at this time. Members show concerns in knowingly allowing anyone open access to our property, also, setting precedence for any other neighbors to unlawfully build on our property. Further, allowing the structure to stay may eventually grant the neighbor ownership to the piece of property with an additional 10 foot set back. Members agree that we want to be good neighbors but do not want the risk of land loss or liability.
