This included the completion or near completion of four projects, #101144, 101157, 101160 & 101165. FISH #101156 Furnace Replacement is in process with some supply delays. FISH 101159 Community Restroom Upgrades has secured a contractor and supplies are on order, FISH 101161 Flat Roof Replacement is about to advertise for a contractor, FISH 101164 Water Lines is about to be in design phase. Lastly, we had a waterline leak at 667-2 that spiked the water/sewer bill. An emergency repair was completed and an abatement has been applied for through the water department.
