### MINUTES

Motion is made by Commissioner Feeley second by Commissioner Brunelli, to accept the Minutes of the Regular Meeting of March 7, 2022. All in favor. So voted.

- Move FYE 2023 Budget on Agenda Motion is made by Commissioner Feeley second by Commissioner Brunelli, to move the review of the budget and the presentation from the Fee Accountant up on the Agenda. All in favor. So voted.
- FYE 2023 BUDGET Richard Shaw of Milne, Shaw & Robillard, PC is the Fee Accountant for the FHA and is here to review the financial health of the agency and present the FYE 2023 budget. A review of the February 2022 Operating Statements started the presentation. Mr. Shaw progressed to presenting the budget highlighting the following: reserve level is very healthy at 70.1% of Maximum, DHCD has allowed \$6000 for legal services and \$1500 for technology improvement exemptions for this budget, current restricted reserves are at \$300K, 4% increase to the Admin Salary line, ED salary schedule, bonuses and Management Agreement income increases recognized, L & I rate increases for maintenance and the schedule of non-routine items. Other program budgets including the 689-1, 689-A, Other Houses and the Management Agreement with Norfolk were presented and all are in good shape.

# ACCOUNTS PAYABLE

Motion is made by Commissioner Feeley second by Commissioner Brunelli to approve Accounts Payable for March 2022 totaling \$158,245.30. Check numbers 26443 to 26493. All in favor. So voted.

Motion is made by Commissioner Feeley, second by Commissioner Brunelli to approve the credit card purchases for February 2022 totaling \$631.93. All in favor. So voted.

- 667-1 Building Fire Update Units are all leased! We have 2 new residents and 2 FHA residents transferred into this building.
- Currently we have two tenants interested in filling the Tenant Board Member position. Tenants have until April 28th to submit a letter of interest.
- Land Encroachment Town met with the neighbor and are now waiting for a response from the neighbor regarding how they plan to correct the issue. BOH has also addressed this issue. FHA will wait for the results of the Town's actions.

- Contract for Legal Services Motion is made by Commissioner Feeley, second by Commissioner Brunelli to accept the contract for Legal Service from Curley & Curley, PC. All in favor. So voted.
- Proposal from Joel D'Errico Motion is made by Commissioner Feeley, second by Commissioner Kepple to give Mr. D'Errico a letter of support for his plan to build a development and restrict all first floor units to seniors and designate them as Affordable Units. All in favor. So voted.
