ABATEMENT APPLICATIONS <u>MUST</u> BE RECEIVED BY THE ASSESSORS WITHIN THREE YEARS AFTER THE EXCISE WAS DUE, OR ONE YEAR AFTER THE EXCISE WAS PAID, WHICHEVER IS LATER. TO PRESERVE YOUR RIGHT TO APPEAL, YOU MUST FILE ON TIME. BY LAW, ASSESSORS MAY ONLY ACT ON LATE APPLICATIONS IN LIMITED CIRCUMSTANCES WHERE THE EXCISE TAX IS STILL UNPAID AND THEIR DECISION IN THOSE CASES IS FINAL.

FILING AN APPLICATION DOES NOT STAY THE COLLECTION OF YOUR EXCISE TAX BILL. TO AVOID INTEREST, CHARGES AND COLLECTION ACTION, INCLUDING NON-RENEWAL OF YOUR REGISTRATION, YOU MUST PAY THE BILL IN FULL WITHIN 30 DAYS OF ITS ISSUE DATE. YOU WILL RECEIVE A REFUND IF AN ABATEMENT IS GRANTED.

NOTE

YOU ARE <u>NOT</u> ENTITLED TO AN ABATEMENT IF YOU (1) CANCEL YOUR REGISTRATION AND RETAIN OWNERSHIP OF THE VEHICLE, OR (2) MOVE TO ANOTHER MASSACHUSETTS CITY OR TOWN DURING THE CALENDAR YEAR. NO EXCISE TAX MAY BE REDUCED TO LESS THAN \$5.00 UNLESS THE EXCISE TAX IS ABATED IN FULL. NO ABATEMENT OR REFUND MAY BE MADE FOR AN AMOUNT THAT IS LESS THAN \$5.00.
