J. OLD BUSINESS

- 1. Recap Franklin Cultural Festival. Talk given by Karen A. was very well received. She can give other talks, including WWII fashions. To increase audience size in the future, we discussed taking an ad out in the Franklin Gazette.
- 2. Long discussion about combining the Fourth of July Festival with the Franklin Cultural Festival. Pros and cons on each side.
- 3. National Register signs for the downtown (Jeremy) Ongoing.
- 4. Eagle Scout Project We hope to have the updated Museum website go live in September.

- 11. Printing press Hampton College needs to research whether they are entitled to deaccession this press to us.
- 12. Roger Calarese request for historical info about the site at Horace Mann Square. We discussed funding for this endeavor (a standing plaque). We can use pictures that we have from display cases and from downstairs.
- 13. Museum interns/future direction Mary discussed the possibility of grants for the MAP (Museum Assessment Program) or CAP (Conservation Assessment Program). She has discussed this with Jaime Hellen. The money would fund a consultant who could help us formulate a multi-year plan. Mary plans to contact NEMA for more information. A motion to submit grant proposals for both MAP and CAP passed 5-0.
