Project Narrative Margaret's Cove Subdivision Modification Franklin, Massachusetts

Background

In January 1982, the Town of Franklin Planning Board voted to approve and endorse the plans entitled "Mine Brook Estates – A Subdivision in Franklin, Massachusetts" dated August 18, 1981, last revised November 6, 1981 prepared by Guerriere & Halnon, Inc. The majority of the subdivision has been constructed with the exception of the remaining (9) lots off Margaret's Cove.

Project Description

The proposed site is located on approximately 6.5+/- acres at the northwestern portion of Mine Brook Estates and has never been developed. The site is located within a Water Resource District and directly abuts the Town of Franklin's water supply Well No. 7 to the southeast and a 20-foot wide sewer easement for the Charles River Pollution Control District and Army Corps of Engineers easement run along the northeastern and western portion of the site.

The Applicant is proposing to construct the previously approved 600' +/- road and modify the previously approved subdivision, which will reduce the amount of proposed lots from 9 lots to six lots that will conform to the current zoning regulations. Additional work will include stormwater management improvements, including drainage infrastructure and detention pond.

Wetland delineation of the property was conducted in March 2019 by Goddard Consulting and a copy of the report has been attached for reference. Based on the recent wetland delineation report, approximately 200+/- linear feet of the previously approved road, including the installation of utilities is within the 50-foot to 100-foot buffer zone to the bordering vegetated wetlands.

Mitigation Measures

Mitigation measures, including erosion control will be installed prior to commencing construction activities and will be maintained for the duration of the project. No negative impacts to the resource areas are anticipated.


