# 1/8/2023

# Motor Vehicle Crash 126 Grove Street

On Sunday, 1/8/2023 at approximately 2:01 pm Officers responded to 126 Grove Street for a report of a motor vehicle crash. No injuries were reported, and one vehicle was towed from the scene.

# 1/9/2023

# Motor Vehicle Fire Wachusett Street

On Monday, 1/9/2023 at 2:28 pm Officers responded to the area of Wachusett Street for a report of a possible vehicle fire near a residence. It was determined there was no vehicle fire but rather a controlled barrel fire.

# Motor Vehicle Fire Highwood Drive

# Motor Vehicle Crash Panther Way @ Highwood Drive

Upon arrival officers found 3 occupants (2 children) in the car and the front driver's side door was caved in. The children were removed from the car and the FFD arrived and used the jaws of life to remove the driver's door. The driver of the vehicle was transported to the hospital.

On Saturday, 1/14/2023 at 9:53 pm Officers responded to a residence in Franklin for a report of a person making suicidal statements. Upon arriving it was determined the individual was not at the residence. A BOLO was put out area wide with the person's information and a cell phone ping was started.
