4/2/2023

Motor Vehicle Crash 268 West Central Street

On Sunday, 4/2/2023 at approximately 3:17 pm Officers responded to 268 West Central Street for a two-car crash. One vehicle side swiped another. There were no reported injuries, and a crash report was completed.

On Tuesday, 4/4/2023 at approximately 10:24 am Officers responded to 390 King Street for a motor vehicle hit and run. It was reported the victim was brake checked while coming off the highway. The other involved party left the scene. There were no reported injuries. An investigation was opened.

On Tuesday, 4/4/2023 at approximately 1:02 pm an Officer was traveling on Union Street when they observed a motorist driving who they knew to have an active warrant for their arrest. On Wednesday, 4/5/2023 at approximately 5:03 pm Officers responded to the Big Y for a report of an unruly patron causing a disturbance. It was reported a man was wearing a ski mask sitting is his car listening to music loud in the Big Y parking lot. Another patron walked by this vehicle and the patron wearing the ski mask began yelling at the other patron. Both parties were separated, and one party was trespassed from the property.

Overdose Franklin

On Wednesday, 4/5/2023 at approximately 7:26 pm Officers responded to an address in Franklin for an overdose. One party was transported to the hospital by the FFD.

4/6/2023

Motor Vehicle Crash 52 East Central Street

On Thursday, 4/6/2023 at approximately 4:41 pm Officers responded to 52 East Central Street for a two-car crash. There were no reported injuries, and a crash report was completed.

Motor Vehicle Violation West Central Street

On Thursday, 4/6/2023 at approximately 5:40 pm an Officer observed a motor vehicle violation in the area of West Central Street and Union Street. The vehicle was stopped and after an investigation the operator, a 45-year-old Bellingham resident received a criminal summons for:

-Operating an uninsured motor vehicle -Operating a motor vehicle with a suspended registration -Operating an unregistered motor vehicle

Well-Being Check Innsbruck Way

On Thursday, 4/6/2023 at approximately 7:34 pm Officers responded to a residence on Innsbruck Way for a well-being check. An individual walked to another residence and reported they were being held hostage. It was apparent the individual was suffering from memory loss. Officers reunited the individual with family members and silver alert information was provided.

4/7/2023

Catalytic Converter Theft/Arrest Emmons Street

On Friday, 4/7/2023 at approximately 3:01 am Franklin Police was contacted by Dean College Public Safety. Dean College Public Safety Officers were monitoring their security cameras in Jones Lot off Emmons Street when they observed two males who had jacked up two vehicles in the lot and appeared to be cutting out the catalytic converters. The subjects were reported to be operating a black sedan.

Franklin Police responded and observed a vehicle matching the description pull out of the Jones lot. When the occupants observed the approaching police units, the vehicle pulled

into a driveway and the operator fled on foot. The passenger of the vehicle, identified as DaMareon Crook, remained in the vehicle and was subsequently arrested. It was later determined that the vehicle used by the subjects was a rental car and the license plate that was attached to the vehicle was stolen.

A perimeter was established, and the area was search by Franklin Police Units with the assistance of Wrentham and State Police. The driver could not be located. After investigation, DaMareon Crook, age 20, from Lorain, Ohio, was arrested and charged with possession of burglarious tools, two counts of larceny by stealing, seven charges of receiving stolen property (catalytic converters), two counts of defacing or damaging property, attaching registration plate, and use of a motor vehicle in the commission of a felony.

Detectives are currently investigating and trying to identify the operator who fled on foot.

Motor Vehicle Crash Depot Street

On Friday, 4/7/2023 at approximately 11:47 am Officers responded to Depot Street for a tractor trailer that struck a telephone pole and took down wires. National Grid responded and reset the pole. A crash report was completed.

Motor Vehicle Hit & Run Depot Street

On Friday, 4/7/2023 at approximately 11:54 am Officers to Harborwood Drive for a motor vehicle hit and run. A vehicle struck a dog and did not stop. An investigation was opened, and the dog appeared to suffer non-life-threatening injuries.

Motor Vehicle Violation West Central Street

On Friday, 4/7/2023 at approximately 8:21 om an Officer was conducting traffic enforcement on West Central Street when they observed a motor vehicle violation. After stopping the vehicle, it was determined the operator did not have a valid license. The operator, a 29-year-old Franklin resident received a criminal summons for:
