After April 1 <sup>st</sup> (Late dog registration fee, spayed/neutered)	\$50.00
After April 1 <sup>st</sup> (Late dog registration fee, not spayed/neutered)	\$60.00
After July 1 <sup>st</sup> Notice of Violation Filed with Wrentham District Court	\$100.00
