Tobacco 2023 Sales Regulation restricting the sale of tobacco and vape products

Director Liberty gave the board the draft regulations to review for the March meeting.

Rescind Chapter 261 Tobacco products

Director Liberty noted that the Town Clerk has begun the process of rescinding the regulations.

2023 Sales Regulation

SAMPLE REGULATION RESTRICTING THE SALE OF TOBACCO AND VAPE PRODUCTS

THIS MODEL REGULATION INCORPORATES THE FOLLOWING:

- 1. The minimum standards required pursuant to the United States Food and Drug Administration relative to the sale and distribution of cigarettes; and
- 2. The minimum standards required pursuant to Massachusetts state law and regulation. This includes G.L. c. 270 regarding sales to those under 21, tobacco and vaping product sales including flavored products, required signage, matching definitions and other relevant state statutes and regulations.





Communicable Diseases:

- **COVID-19 cases** (data from 2/28/23, data is subject to change):
 - -Total cases thus far for February, 2023: 70 (versus 142 in January, 2023).






- -COVID-19 clusters and other communicable disease case investigations (Norovirus).
- -COVID-19 iHealth rapid test kits available for Franklin residents, expiration date 8/19/23.

Influenza

- -Influenza severity for Massachusetts is low this week.
- -The percent of influenza-like illness (ILI) visits in Massachusetts is 1.85%, which is lower than the regional baseline of 2.0%.

Percent of visits for influenza-like illness (ILI) reported by sentinel provider sites in Massachusetts



- -The percent of hospitalizations associated with influenza is 0.25%, which is slightly higher than two of the previous three seasons in the same week.
- -More influenza A than influenza B positive specimens have been reported by hospitals and outpatient facilities in Massachusetts.
- -The vaccination rate for all ages is 45%.
- -Seasonal influenza activity is low nationally.

Franklin/Norfolk/Wrentham Dashboard

- In the month of February there were 70 confirmed COVID-19 positive cases. 82% of Franklin residents are fully vaccinated, 56% have their first booster, and 27% have had their second booster shot. There were 0 COVID-19 related deaths in the month of February. Confirmed cases have decreased 46% from January to February.
