# RESCIND BORROWING AUTHORITY (RESOLUTION 16-20 APPROPRIATE AND AUTHORIZE BORROWING OF FUNDS TO PAY COSTS OF THE CONSTRUCTION OF SIDEWALKS AND RELATED WORK) FUND THROUGH APPROPRIATION

Whereas: The Town Council previously adopted Resolution No. 16-20, April 6, 2016 which

appropriated \$277,913.61 from DPW Stabilization account and \$22,086.39 from Free Cash, and authorized a borrowing of \$1,500,000 to pay costs for the construction of

sidewalks and related work.

Whereas: The Town now wishes to rescind said borrowing of \$1,500,000, and the borrowing

portion of Resolution No. 16-20 is of no further force or effect.

Whereas: The Town now wishes to fund said project in the amount of \$1,500,000 by Raising

and Appropriating \$1,261,000 and \$239,000 from Free Cash.

#### NOW THEREFORE BE IT ORDERED by the Town Council of the Town of Franklin that:

to meet the appropriation made under Resolution No. 16-20 to pay costs for the construction and sidewalks and related work, an amount of \$1,261,000 shall be Raised and Appropriated and \$239,000 is hereby appropriated from Free Cash, and the \$1,500,000 borrowing authorized by Resolution No. 16-20 is hereby rescinded and of no further force or effect.

The Town Administrator is authorized to take any other action necessary or convenient to carry out this project and this Resolution.

This Resolution shall become effective according to the rules and regulations of the Town of Franklin Home Rule Charter.
