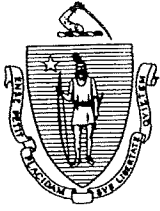

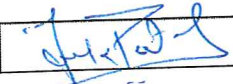

STOCK SALE AGREEMENT

Agreement made as of this 22nd day of August, 2017 by and between Jack Patel (hereinafter called "Seller"), and Mahendra Patel and Kanchan Patel (hereinafter collectively called "Buyer") and Ashadeep, Inc., a Massachusetts corporation (hereinafter called "Company").

WITNESSETH

Whereas, Seller as owner of One Hundred (100%) Percent of the issued and outstanding shares of the stock of Company (hereinafter called "the Stock") is desirous of selling a Fifty (50%) Percent interest in Company to Buyer (25% share to Mahendra Patel and 25% share to Kanchan Patel); and

Whereas, Buyer is desirous of acquiring a Fifty (50%) Percent interest in the Company as follows;

Now, Therefore, in consideration of the premises and of the mutual covenants herein contained, the parties hereto agree as follows:

1. *SALE OF THE STOCK*: Subject to the terms and conditions hereof, Seller shall transfer to Buyer, and Buyer shall acquire from Seller Fifty (50%) Percent of the Stock of the Company.
2. *SELLER'S REPRESENTATIONS AND WARRANTIES*: Seller represents, warrants and agrees to and with Buyer that:
 - (a) Company is a corporation duly organized and existing and in good standing under the laws of the State of Massachusetts, has the corporate power to own its properties and to carry on its business as now being conducted and is duly qualified to do business and is in good standing in every state in which the nature of the business conducted by it makes such qualifications necessary, and the copies of Company's Articles of Organization and all amendments thereof.
 - (b) There is no action or proceeding or governmental investigation pending or, to the knowledge of Company, threatened against Company before any court or administrative agency, the determination of which might result in any material adverse change in the business of Company or in the value of the assets.
 - (c) Company has good and marketable title to the assets described in Exhibit A attached hereto and made a part hereof free from all encumbrances.
 - (d) Company is not a party to any contract or agreement or subject to any charter or other corporate restriction which materially and adversely affects its business, properties, assets, or financial condition, and neither the execution nor delivery of this agreement nor the consummation of the transactions contemplated hereby, nor the fulfillment of the terms hereof, nor compliance with the terms and provisions hereof will conflict with or result in a breach of the terms, conditions or provisions of, or constitute a default under, the certificate of incorporation or by-laws of Company or of any agreement or instrument to which Company is now a party;

(e) Company has full power and authority to enter into this Agreement and the execution and delivery of this Agreement have been duly authorized by the Board of Directors of Company;

(f) Company has no outstanding funded debt or liability for borrowed money except those set forth in Exhibit B attached hereto and made a part hereof

3. **PURCHASE PRICE OF THE STOCK:** The agreed purchase price for the Stock is Seventy-Five Thousand Dollars (\$75,000.00) (\$37,500 from Mahendra Patel and (\$37,500.00 from Kanchan Patel)

4. **THE CLOSING:** Sale of the Stock and payment therefor and other acts to be done at the time thereof, as herein provided, shall take place within 7 days of the Approval by the ABCC of the liquor license transfer (hereinafter called the "Closing Date") or such other time and place as may be agreed upon by all of the parties in writing. Based upon the foregoing and subject to the terms and conditions herein set forth, the parties hereby agree that at the closing:

(a) Buyer will deliver to Seller the checks, notes and executed agreement specified in paragraphs 3 and 4;

(b) Seller will deliver to Buyer (i) all the corporate books of the Company, (ii) duly executed stock power transferring all of the stock of the Company to Buyer and (iii) written resignations of all officers and directors of Company in form acceptable to Buyer.

5. **INDEMNIFICATION AND SET-OFF:** Seller agrees to and shall indemnify Buyer and its successors and assigns, in respect of any damage or deficiency resulting from any misrepresentation, breach of warranty, or nonfulfillment of any agreement on the part of Seller under this Agreement, or from any misrepresentation in or omission from any certificate or other instrument furnished or to be furnished to Buyer hereunder.

6. **ADDITIONAL CONDITIONS:** The obligations of Buyer under this Agreement are subject to and conditional upon the fulfillment, prior to or on the Closing Date, of each of the following conditions:

(a) The representations and warranties of Seller contained in this Agreement shall be true on the Closing Date as though such representations and warranties had been made at and as of such time.

(b) Seller shall have performed and complied with all conditions and agreements required by this Agreement to be performed or complied with by them prior to or on the Closing Date.

(c) Since the execution date of this agreement, the assets, properties and business of Company shall not have been materially or adversely affected as a result of fire, explosion, accident, strike, lockout, flood, drought, embargo, war, riot or act of God or the public enemy.

(d) On the Closing Date Company shall not be a party to, or to the best of their knowledge threatened with, any material litigation or legal proceeding before or

investigation by any governmental agency, except the environmental impact study as previously discussed.

(e) The assets listed in Exhibit A are still owned by Company on the Closing Date.

(f) Buyer has been approved by the ABCC and the Local Licensing Authority, as the new holder of the Liquor License associated with the premises.

7. *BUSINESS CONDUCT PRIOR TO CLOSING*: From the date of this agreement and until the closing:

(a) Company's business shall be conducted only in the ordinary course;

(b) No change shall be made in Company's Articles of Organization or By-Laws except as may be first approved in writing by Buyer;

(c) No dividend or other distribution or payment shall be declared or made in respect of Company's capital stock, nor will Company directly or indirectly redeem, purchase or otherwise acquire any of such stock, except as may be first approved in writing by Buyer;

(d) No increase shall be made in the compensation payable or to become payable by Company to any officer, employee or agent, nor shall any bonus payment or arrangement be made by Company to or with any thereof, without the Buyer's prior written approval;

(e) Except as otherwise requested by Buyer but without making any commitment on behalf of Buyers, Company will use its best efforts to preserve its business organization intact; to keep available to Buyer the services of its present officers and employees; and to preserve for Buyer the goodwill of Company's customers and others having business relations with it.

8. *SURVIVAL OF REPRESENTATIONS* : All representations and warranties made in this Agreement or in any certificate delivered or deliverable at the closing by any party shall survive the Closing Date and shall remain operative and in full force and effect notwithstanding any investigation on the part of any party. Every statement *made* in any certificate, opinion or letter delivered or deliverable to any party or to counsel for any party on the Closing Date shall be deemed a representation and warranty made in this agreement by the party by whom such item is delivered or deliverable. Every such statement made by an officer, agent, counsel or accountant shall be deemed a representation and warranty made by the party employing or retaining the maker of the statement.

9. *CONSTRUCTION OF AGREEMENT*: This Agreement is to be construed as a Massachusetts contract, is to take effect as a sealed instrument, sets forth the entire contract between the parties, is binding upon and enures to the benefit of the parties hereto and their respective heirs, devisees, executors, administrators, successors and assigns, and may be cancelled, modified or amended only by a written instrument executed by Seller Buyer and Company.

10. *NOTICES*: All notices, requests, demands and other communications hereunder shall be in writing and shall be if mailed first class postage prepaid

(i) if to Seller to the address described in the opening paragraph of this agreement with a copy to;

(ii) if to Company to the address described in the opening paragraph of this agreement; and

(iii) if to Buyer to the address described in the opening paragraph of this agreement with a copy to Attorney Matthew S. Porter, Vieira & DiGianfilippo, 480 Turnpike Street, South Easton, Massachusetts 02375.

11. *DEPOSIT*: \$1,000.00

12. *DEFAULT*: In the event one or more of the conditions set forth in paragraph 7 have not been fulfilled at the closing then, at the Buyer's discretion, the deposit made by Buyer under paragraph 13 shall be immediately refunded and all other obligations of all of the parties hereto shall cease and this agreement shall be void and without recourse to any of the parties hereto. The Buyer shall have the election to continue on with the agreement despite any breach.
