**<u>ACTION</u>**: The Council approved a resolution to transfer two town owned parcels of vacant land to Care, etc. of the Conservation Commission. *Approved 8-0*.

2. *Resolution 17-53: Dissolution of Horace Mann Statue Committee (Motion to Move Resolution 17-53 – Majority vote (5))*
