## **REVIEW OF MEETING MINUTES**

Review of May 5, 2020 and May 21, 2020 minutes. Motion made to accept minutes, Vice Chair Cochrane, Second by Member Harris, Motion to accept by Vice Chair Cochrane, it was voted unanimously to accept the minutes. Chair Sweet conducted a roll call.

### **NEW BUSINESS**

#### **A. Discussion of Local Beach Regulations**

Director Liberty noted that under the MGL 111, Chapter 31, Section 104: Prevention of spread of infection she asked the board if they want to consider beach regulation to provide education to the beach goers on social distancing, the number of people in a household allowed, face coverings, etc. Chair Sweet asked Ryan Jette if residents have been at the beach. Ryan stated there are signs at the beach about social distances, etc. and no beach goers are adhering to the social distancing or face coverings. The board briefly discussed that enforcement is an improbable expectation of the regulation and decided not to pursue beach regulations.

#### **B. Discussion of Mold and Legionnaires Guidance**

Director Liberty brought the guidance to the board's attention and is educating the business community on the need to make sure their water is safe to use to minimize the risk of Legionnaire's disease by providing the guidance from the CDC on the COVID 19 portal on the website.

#### **C. Recreational Camp Guidance**

Director Liberty noted that the minimum requirements for recreational camps discusses staffing and operations, group sizes and rations, screening and monitoring of children and staff, isolations and discharge of sick children and staff, hygiene, and health practices and personal protective equipment.

#### **D. Reopen food establishments outdoor dining**

Director Liberty noted that the governor will speak to when the outdoor dining can commence in Phase 2 and when he does the food establishments will have to adhere to the sector specific safety protocol which are social distancing, cleaning and disinfecting, hygiene protocol and staffing and operations. They also have to have a written COVID 19 Control Plan and an Attestation posted at the establishment. The establishments will also have to adhere to the Town's permitting process too.

Chair Sweet addressed a participants question regarding recreational camps guidance.
