**RE:** Capital Requests & Borrowing Authorization

There are two remaining issues I would like formal recommendations on from the Finance Committee that have interrelated issues with the overall FY21 Town Budget. Additional Capital requests and a Borrowing Authorization legislation.

### Capital Requests

I am proposing three additional capital items to be funded through excess Free Cash. As we had a very warm winter, the town did not have to use any of the set aside \$800,000 in free cash that was set aside in the normal capital process this year. As a result we have 3 issues that I am requesting funding for for projects that require immediate attention:

- 1. Electrician Van \$45,000 our old van will not pass inspection and will be auctioned. To maximize our staff potential, a new van for our Town Electrician is required. This is even more critical given the cuts to outside contracting we will need to make in FY21.
- 2. Virtual Server Replacement \$110,000 The second half of funding for required work to our virtual servers, which includes the necessary hardware, as detailed in the attached quote, to provide a robust, redundant, fault-tolerant computing system. This system will be a locally hosted virtual environment utilizing DELL/EMC Storage Spaces Direct, Azure\* Stack HCl arrays (or equivalent hardware) running Hyper-V clustering via Microsoft Windows Server Datacenter®. The warranties expire at the start of the fiscal year and we need to protect our servers.
- 3. Roads & Infrastructure \$350,000 As we weigh the future of what the Town can afford to do roads and infrastructure work, this appropriation will allow the DPW to continue on with projects for this year that have already begun, been bid, and puts us in a position to finish off some work.

After these considerations, the Town will have an additional \$329,296 in free cash available. This free cash will be needed to be set aside in the order any additional equipment is needed in an emergency or for any COVID-19 uses that are not anticipated. With cash flow so low, these extra monies could be useful.

#### Ambulance

Additionally, I am requesting authorization for \$350,000 for a new ambulance. See the attached quote and specs. This is an issue I failed to bring forward through the traditional capital process in January, as the funding source is not the typical process with free cash. It's through Ambulance receipts. This replacement Ambulance is on its regular replacement schedule in the capital plan.

#### **Borrowing Authorization**

As we'll discuss tomorrow evening, the Town's debt service schedule is anticipated to decline in FY22 and beyond quite rapidly with projects coming off the schedule. The Town will need to have this authorization to properly maintain operating budget funds for debt service. This is a critical funding source to maintain all of our town schools and municipal buildings.

The attached sheet reflects the next big projects on the capital list for the next 3-5 years that eclipse a \$1 million price tag and fit within the policy. It is important to note there is no guarantee these projects will be funded. With an altering market, it gives the Town financial flexibility to be able to maintain our facilities if market prices are favorable to the Town.

As many know, the Town has traditionally used Free Cash and grants to fund most capital projects, including many of the upgrades to our facilities. Due to the economy, we expect to see a large reduction in free cash over the next two years as the economy ebbs and flows. Approving this legislation will greatly enhance our ability to be prepared if free cash stays low and we need funding to keep our facilities in top notch shape. Ultimately, this may be our only option to fund these projects in the near term.

<b>Estimate</b>	<u>Building</u>	Project Description
\$1,400,000	Municipal Building	The windows and facade of the Municipal Building are in deserpate need or replacement due to extreme leaks of many windows. The cost estimate also includes general renovations to bathrooms, carpets and the mechanicals of the building (boiler, etc).
\$3,123,500	Technology	For major infrastrure needs for the Technology Department. The funds allocated here are for two buckets (1) emergency facilities improvemenst possibly needed for COVID-19 implementation in schools or remote learning and (2) Overall equiopment needed to sustain our school and town wireless access points, projectors, switches, etc. Tim has been preparing this plan for many years and the Town has traditionally funded items on an as-needed basis through the annual capital program. We expect free cash to drop significantly and may be better off borrowing and making the proper investments during these changing economic times.

I am also working with the DPW to possibly look at a long-term Sidewalk Master Plan, much lik we do for roads. \$3,000,000	Remington-Jefferson	An estimate to rebuild the roof (\$1.75 million), boilers, basketball court, fire alarms.
\$1,000,000	Parmenter School	An estimate to replace the Boilers and Playground
\$1,500,000	High School	An estimate to do a ten-year upgrade/retrofit of aspects of the High School that need future attention, including the bleachers, kitchen, Mac Labs, Fitness equipment, sound recording, engineering lab, auditorium, air conditioning and any other incidentals.
\$3,000,000	Recycling Center	For a future rehab to the Beaver Street Recyling Center. We will be complete with the lan swap by end of calendar year. A required solid waste master plan will be required by DEP. Once we get to that point, we will evaluate a new station and state requirements from the master plan. We are least a few years away.

Attached are two of the three quotes. One is for the rescue and is inclusive of all Frazer equipment. Second is the chassis radio. Waiting on the third, which is the module 2-way radio, but the last one cost us \$4600.

Total as of today is projected at \$332,739.73, which is just a bit under the \$335,000 put in the capital plan. We may want to just assume the \$335,000 to have a couple thousand for misc equipment.

This all being said, if we add the new brackets and two new computer tablets for the vehicle it would be an additional \$10-\$12,000 which would round out to \$350.000.00. My understanding is that the computers for the new ambulances were not taken out of this fund in the past. It seems to be appropriate to take it out of here instead of another line item but I will defer to you and Chris on that.

Short answer, \$335 without two new tablets, \$350 with two new tablets installed.
