- **ACTION:** The Council approved a resolution to amend the FY19 Budget from \$126,618,521 to \$127,261,441 to raise and appropriate and transfer funds. *Approved 9-0*.
 - c. Resolution 18-60: Appropriation General Stabilization Fund (Motion to Approve Resolution 18-60- Majority Vote (5))
- **ACTION:** The Council approved a resolution to raise and appropriate and transfer \$875,000 to the General Stabilization Fund. *Approved 9-0*.

- **ACTION:** The Council approved a resolution to raise and appropriate \$575,000 for DPW- Public Way improvements including but not limited to design, engineering, pavement reconstruction, sidewalk construction, drainage installation and ancillary grading and landscaping said amount being the approximate total to be received from the hotel excise tax in FY19. **Approved 9-0.**
