- a. Resolution 18-51: Verizon Cable License Renewal (**Motion to Approve Resolution 18-51 - Majority Vote (5)**)

ACTION: The Council approved Resolution 18-51 to renew the Verizon Cable License with the Town of Franklin with a license term of 5 years . *Approved 9-0.*

- b. Resolution 18-52: Acceptance of Gift to the Senior Center (**Motion to Approve Resolution 18-52 - Majority Vote (5)**)

ACTION: The Council approved resolution 18-52 to accept a generous gift of \$1,100 from the Picillo Family in honor of Emily Picillo. *Approved 9-0.*

- c. Resolution 18-53: Library Budget (**Motion to Approve Resolution 18-53 - Majority Vote (5)**)

ACTION: The Council approved resolution 18-53 to amend the FY19 Budget from \$126,519,822 to \$126,618,521 by raising and appropriating funds in order to increase the FY19 Library budget from \$900,301 to \$999,000, ensuring for the first time in a over a decade the Town does not have to apply for a waiver of the Minimum Appropriation Requirement (MAP) with the state. *Approved 9-0.*

- d. Resolution 18-54:Ratification of the Memorandum of Agreement between the Town of Franklin and the Franklin Police Association (**Motion to Approve Resolution 18-54 - Majority Vote (5)**)

ACTION: The Council approved resolution 18-54 to ratify the Memorandum of Agreement between the Franklin Police Association and the Town of Franklin, 4X4- Ten Hour Per Day Work Rotation. *Approved 9-0.*
