Would you please forward these comments to the ZBA members to be included into the public record for Thursday night's public hearing for the 121 Grove St 40B project. I am going to be out of the country and unable to attend the hearing.

Dear Chair Hunchard and members of the Franklin ZBA,

I have attached

I respectfully request that the following comments be read at the public hearing Thursday night. I am a resident of Benjamin's Landing, which is about .3 of a mile from the proposed 330-unit rental apartment complex located at 121 Grove St. I am reiterating my concerns that I brought before the Board at the February 15th public hearing. I am extremely concerned about the additional traffic that this project is expected to generate on an already treacherous Grove Street. If I read the traffic report correctly, this project is expected to generate an additional 1,528 vehicle trips on an average weekday. Benjamin's Landing is a blind drive and I am concerned about the safety of our residents trying to pull out of our driveway onto Grove St.

I Hope the ZBA requests that the developer reduce the number of units of this project as a condition of approval.

I am also have concerns regarding the 4 & 5 story heights of the buildings. From what I can see, there are no other building this high on Grove St. Forge Hill Assisted Living Facility next door is 3 stories.

Has there been any consideration in asking the developer to reduce the height of the building to be more in keeping with the neighborhood?

I am not opposed to this project and I understand the need for affordable housing, but since Franklin is already over our 10% affordable housing unit inventory, I hope the ZBA with take our concerns into consideration when granting waivers and drafting the conditions of approval for this project,

Dear Ms. Thayer & Mr. Hunchard,






