Minimal impact as this space will be used by only two adults. No upgrades of existing water/sewer needed.

We moved to Franklin in 2017 and recently had a son, Joseph. As we expand our family we'd like to have Elena's parents move back in with us to assist with child care. They previously lived with us in a spare bedroom. The proposed project will take place only in the basement of our home and will finish approximately 680 square feet. The space will consist of a living area, bathroom, kitchen with range/oven, and a bedroom. The bedroom will have egress via the existing dedicated basement door/stairway. The oven/range will be properly vented, and wastewater will utilize the existing main drain which is connected to town sewer. Ceiling height will be to code as will all other aspects of construction, and proper permits will be obtained. We are working through a short list of contractors and all have deemed the project doable as described.

Additionally, multi-generational living has been growing consistently in the United States. A 2018 article found on pewresearch.org¹ cited a 2016 study which found that a record number 64 million people, or 20% of the U.S. population lived with multiple generations under one roof. The percentage grew steadily from 12% in 1980 with the biggest jump in recent years. Increasing the number of households able to accommodate multi-generational living in Franklin will increase the overall desirability of our town.




