582 OAK STREET FRANKLIN, MA

A) A literal enforcement of the provisions of the Zoning bylaw would involve a substantial hardship, financial or otherwise, to the petitioner or appellant for the following reasons:

The lot is a "grandfathered" preexisting lot that does not comply with the current zoning bylaws for lot area, build circle, front yard and side yards distances. The Town of Franklin exercised a taking of five feet in the front to allow for a sidewalk to accommodate the Oak Street schools. This resulted in a reduction in the lot area and front yard setback.

B) The hardship is owing to the following circumstances relating to the soil conditions, shape or topography of such land or structures and especially affecting such land or structures but not affecting generally the zoning district in which it is located for the following reasons:

The narrow and skewed shape lot prevents additions without a variance. The existing soil structure is compact glacial till with a relatively high perched water table that makes a garage under very problematic.

- C) Desirable relief may be granted without either:
- 1) Substantial detriment to the public good for the following reasons:

The proposed two-car garage would be a substantial improvement and is consistent with the neighborhood properties. The garage and driveway turnaround will minimize the potential for vehicles backing onto very busy Oak Street traffic.

2) Nullifying or substantially derogating from the intent or purpose of the Zoning Bylaw for the following reasons:

The applicant will remove an existing 8 foot by 10 foot shed that is currently "grandfathered" and is in violation of the sideyard setback. The shed to be removed is closer to the right sideline than the proposed garage.

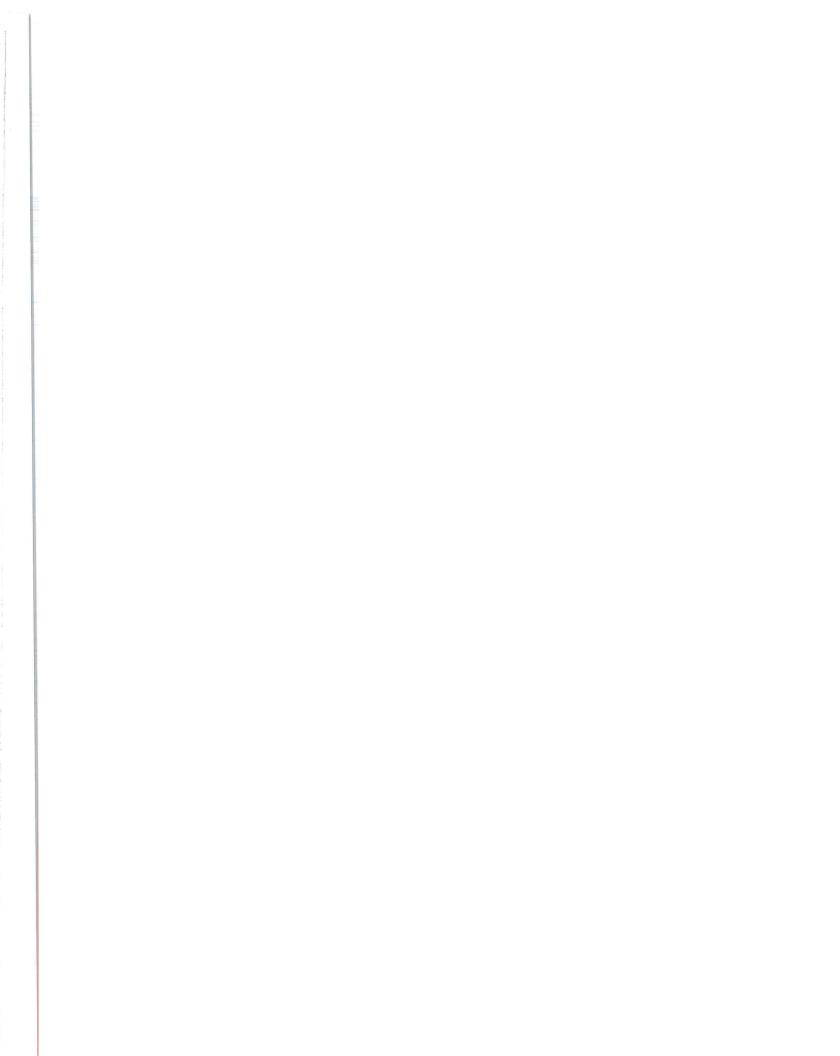

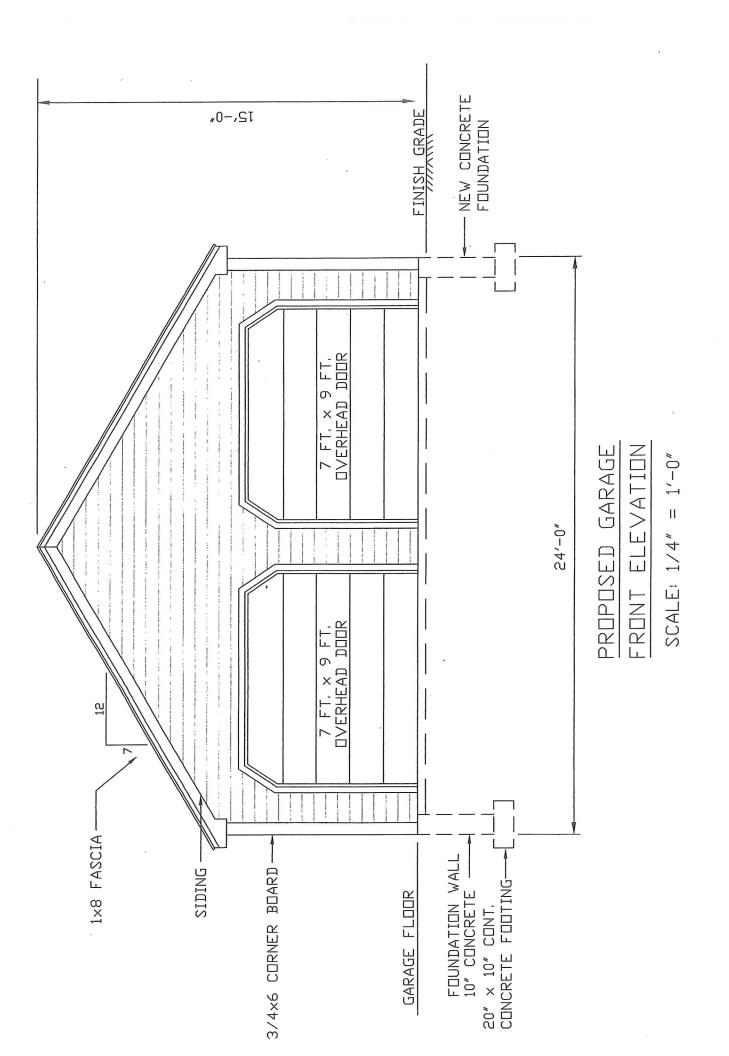
