#### Memorandum In Support Of Robert Glencross Petition for Variance

#### Introduction

This variance petition is brought to alleviate a unique hardship to the petitioner. The existing building was built around the early 1900s and shortly thereafter the owner recorded a plan and deeds dividing the property in half with the property line running "through the center of the house". A thin petition was put up between the first two floors separating the units. This is not a situation involving a common wall as the wall did not provide structural support to two separate structures but rather simply partitioned the first two floors of one house. Thereafter, each half was given to a different daughter of the grantor and the title has descended from there. Mr. Glencross was the first person outside the family to own 1/2 of the house. Unfortunately, Mr. Glencross was allowed to close on the property despite the problems presented by no common ownership of a building, as in a condominium, or common maintenance agreement. Mr. Glencross has a pending claim against the closing attorney. The parties were also engaged in litigation over their obligations to each other in relationship to the house when it was destroyed by fire in August of 2021. Each party would like to now rebuild what is essentially their half of the house. However, they don't want to do this and have each side abutting immediately on the property line and against the other building. This would make reconstruction practically impossible and unable to be in conformance with current building codes. Therefore Mr. Glenncross' proposal is to build on his property on the same footprint of the destroyed property but in the rear of the lot therefore offsetting the two properties and making them two single family homes consistent with the neighborhood. To do this Mr. Glencross is seeking a variance of the rear and side lot lines.

#### Factual Background

I.

 Lawler is the owner of 71 A North Park Street, Franklin, Norfolk County,
 Commonwealth of Massachusetts by a deed recorded with the Norfolk District Registry of Deeds in Book 22329, Page 91 and has a mailing address of 7IA North Park Street, Franklin, MA 02038.

- 2. Glencross is the owner of 71 B North Park Street, Franklin, Norfolk County, Commonwealth of Massachusetts by deed recorded with the Norfolk District Registry of Deeds in Book 34240, Page 55 and has a mailing address of 71 B North Park Street, Franklin, MA 02038.
- 3. Gerald Lawler, Jr. has been the owner of71A since April of 2005, having acquired the premises as the beneficiary under the Lawler Family Trust. The Lawler Family Trust was created in 1994. Prior to the trust ownership of the premises, the property was owned by Lawler's parents, having acquired title to the property in 1975.
- 4. The Lawler Family has continuously owned the Property in good condition and paid all taxes and assessments for a period of approximately 40 +years.
- Glencross and Lawler are the owners of two halves of a common building, 71A
   and 71B North Park Street, Franklin, Massachusetts.
- 6. The property was divided into two halves, with a line running through the center of the house, by deeds approximately one hundred (100) years ago.
- 7. The parties' predecessors in title who resided in the two sides were related parties up until Glencross's purchase.
  - 8. Lawler received his interest in 2005 from a trust set up by his parents.
- 9. Glencross purchased the property on July 5, 2016 by deed dated the same day and recorded in the Norfolk Registry of Deeds at Book 34240, Page 55.
- 10. No common area agreements or party wall agreements were ever created or recorded.
- 11. Since the division of the property over one hundred (100) years ago, the parties have shared a common building, including a sewer drain and portion of sewer pipes.

- 12. On or around August 2021 the building was hit by lightning and destroyed by the resulting fire.
- 13. The parties both want to rebuild their respective homes but separately as the pre-existing common building was not a condominium or with a common area agreement.
- 14. The division of the home in two sections on the lot line prevents functional reconstruction as both sides would be too close to the lot line to even allow access and be separate buildings of varied design and unattractive.
- 15. The parties agreed proposal is for Lawler to rebuild his home as close to in place as viable for Glencross to relocate his home to the rear portion of his lot and prevent the issues described above.

#### 2. SUPPORTING STATEMENT FOR A VARIANCE

- A). A literal enforcement of the provisions of this zoning bylaw would involve a substantial hardship, financial or otherwise, to the petitioner or the appellant for the following reasons: The property is unique in that it had a single-family home that was partitioned and sold prior to the town establishing zoning bylaws. The lot itself is grandfathered but rebuilding the home in the location of the existing foundation would cause it to be too close to the lot line and create problems with current building regulations. By relocating the home to the rear of the lot these issues would be avoided.
- B). The hardship is owing to the following circumstances relating to the soil conditions, shape or topography of such land or structures and especially affecting such land or structures but not affecting generally the zoning district in which it is located for the following reasons: As set forth above this property is unique in that

that a prior owner around 1917 recorded a plan and later deed in which the property line runs through the center of the home dividing it in half as a structure but causing it to be on two separate properties. Upon information and belief this was done to convey the house as two separate properties to the grantor's daughters. This predated zoning and the condominium statute. The result was a house that had been cut in half and each side separated internally by a small partition. Since there is no common maintenance agreement common area agreement or condominium created it would be practically impossible to rebuild the structure as one common building. Moreover, it would be nearly as impossible to construct 2 halves of a house abutting within inches next to each other on the property line.

- C). Desirable relief may be granted without either:
- 1. Substantial detriment to the public good for the following reasons: The new proposed relocated structure will be in a more appealing location on the lot not immediately adjacent to the property line and offset from the structure to be built by Lawler which will be advantageous to the neighborhood.
- 2. Nullifying or substantially derogating from the intent or purpose of this zoning bylaw for the following reasons: Rebuilding the home in the proposed location will bring the property closer to the intent and purpose of this zoning bylaw. The variance sought is only for the rear and side lot lines in an area to the rear of the lot where it is not directly abutting other homes.

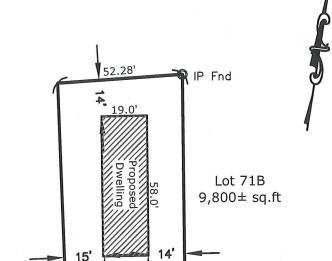

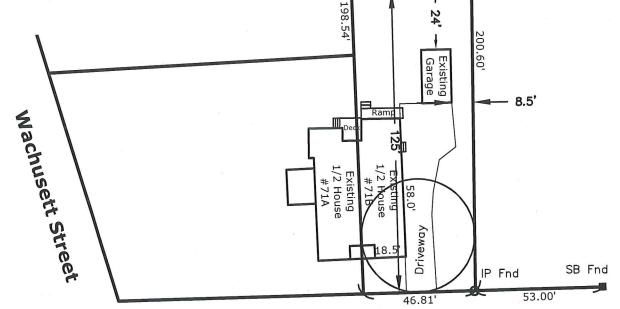
